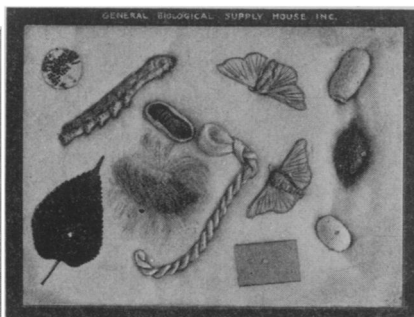
Earthworm Model
