

**Let an experienced journal editor help you get published.**

Consider this: many of the better scientific journals reject 50% or more of the papers submitted. And all too often the cause for rejection isn't bad science, but bad presentation.

In *How to Write and Publish a Scientific Paper*, Robert A. Day has written a handbook which should substantially improve the would-be author's probability of publication. Day is certainly well qualified to address the subject: for the past 18 years he's been Managing Editor of nine journals published by the American Society for Microbiology.

The book itself is a demonstration of clear and concise presentation. Step by step, it covers every aspect of the writer's task—from preparing a title (more important than most people think) to dealing with editors and printers. The chapters on the use and abuse of tables and illustrations and on interpreting letters of rejection are particularly instructive.

Throughout, the point of view is that of a working editor. The style is lively, the treatment often amusing; but the content is thoroughly serious. Much of the information offered here is not readily available elsewhere.

For certain, this is a book you will use—whether you read it from cover to cover or reach for it in times of desperate need. In the words of one reviewer,\* "[it] should be in the hands of young, middle-aged, and old scientists. It should be on the desk of everyone who aspires to write a scientific paper."

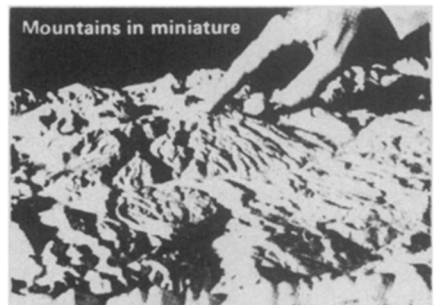

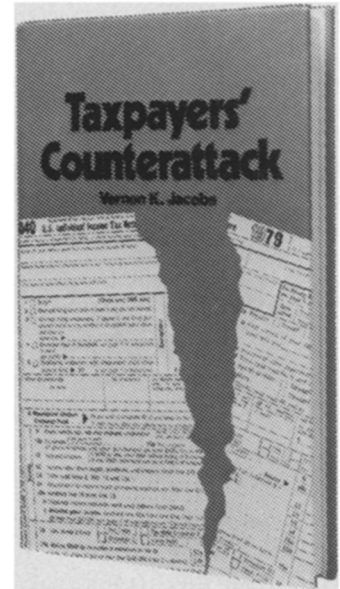

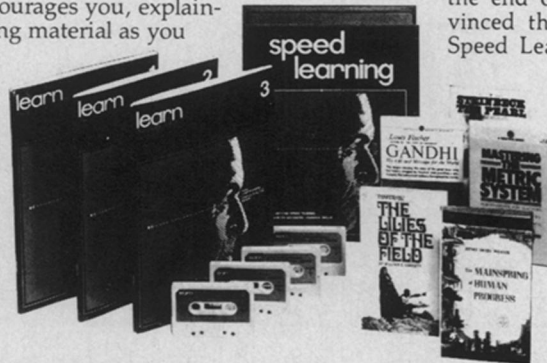
