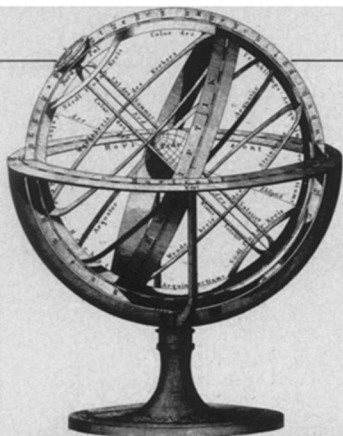




CHANDLER WOBBLE

*Ninety years after Chandler's discovery
this willful polar motion still defies explanation*

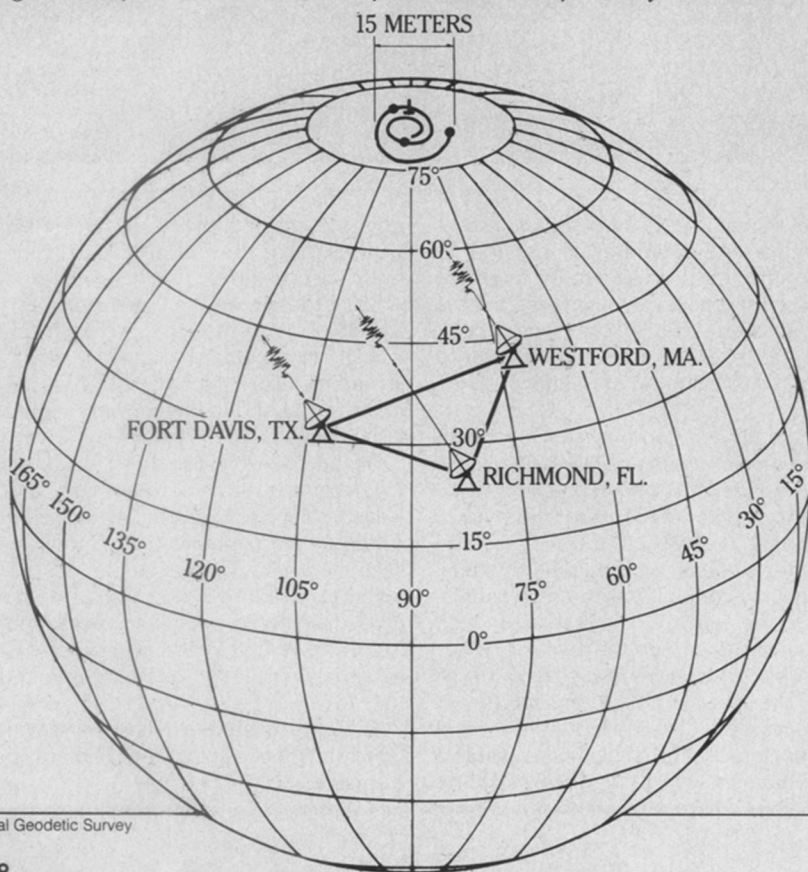

In 1891 an amateur astronomer, Seth Carlo Chandler, diverged from a popular view of the earth's rotation, displeasing the fledgling community of professional astronomers and changing their perception of the earth. He had observed a 14-month wobble in the earth's orientation on its axis of rotation. This unexpected period could be explained only if the earth, considered a solid sphere, was deformable, its poles squashed down and its middle bulging gently.

Theorists claimed that Chandler's analysis, lacking a theoretical underpinning, must be faulty or his observations incorrect. But his conclusions could not be refuted.

Today the existence of the Chandler wobble is widely acknowledged, but its true nature remains a mystery: Its stimulus is still unknown; the wobble is accused variously of causing and being caused by earthquakes, and of instigating changes in the global climate. Sophisti-

cated observations made possible by space technology have transfused new life into the quest for an explanation of the wobble's effects and causes.

The wobble's radius varies from about five to ten meters; its diameter can be compared roughly to the width of a basketball court. Chandler was not the first to guess that such a free motion existed. Leonard Euler, a prominent 18th century mathematician, predicted in 1752 that the earth is capable of wobbling freely, much as a top will wobble, spiraling in and out as it spins at an angle to the floor. Basing his predictions on the laws of inertia, Euler calculated that the wobble would take 304 days. Over the next century a cadre of the era's most notable scientists, including Friedrich Wilhelm Bessel, Simon Newcomb and James Clerk Maxwell, combed existing records of latitude for evidence of a variation to match Euler's theory.

Geodynamicists know now that there is no 10-month wobble. Chandler solved the problem by deliberately abandoning the search for the 10-month period dictated by Euler's elegant theory, instead studying only observations. He saw a wobble that had two periods—one of one year, caused by seasonal redistributions of mass in the atmosphere, and another of 428 days. But scientists were puzzled by why the period of Chandler's wobble differed so dramatically from that Euler predicted. An explanation was found when Newcomb suggested that if the earth was deformable it would respond to rotational forces that would lengthen the period of the wobble. Newcomb's idea explained why the wobble lasted 428 days rather than 304 days. In fact, his calculations were flawed—the actual wobble of a solid earth with no oceans would last 405 days. Still, the notion that the earth's crust slips around the rotation axis gained credence and geodynamics—the study of the forces and processes of the earth's interior—was born.

Much of the modern controversy surrounding the Chandler wobble centers around the search for the wobble's stimulus. The fact that the wobble occurs in the nonrigid earth implies that as its energy is dissipated in the oceans it will damp out in the way that a top slows to a halt as it loses momentum. But it doesn't. In the nearly 200 years since records of latitude have been maintained, the wobble has persisted. People working on the problem think that whatever excites it, be it earthquakes or convection within the liquid core, happens frequently.

The idea that the Chandler wobble is linked to earthquakes enjoys sporadic bursts of popularity but some critical questions remain. For example, how large an area does one earthquake affect? If an earthquake occurs in San Francisco, is the earth deformed half a planet away? According to current theories of the earth's

elasticity, one earthquake is not enough to cause a large wobble. If the wobble is not caused by one or two earthquakes, do quakes exert a cumulative effect?

"Since a big earthquake displaces a lot of mass, it is reasonable to think that this redistribution of mass will have some effect on the rotation of the earth, but the theoretical calculation comes out too small by a factor of two or three," says Edward Flinn, chief scientist of the National Aeronautics and Space Administration's geodynamics program. "Still, there is a distinct possibility that the continuous release of seismic energy would be enough to excite this wobble."

The wobble also perplexes scientists because it varies with respect to radius and, possibly, to period. One explanation for the variation is that different parts of the earth, for example the oceans or the liquid core, may wobble with different frequencies. Their interaction may cause the wobble to appear to vary with time when in fact it is two wobbles of fixed period—not varying with time at all. Chandler himself concluded that the 14-month period is complicated by a major peak at 428 days and a much smaller one at 436 days. Although his observations had once before proved correct in the august face of the "laws of dynamics" the scientific community again rejected his analysis because it conflicted with theory. This reaction still occurs.

"If you put two frequencies that close together you have a 'beat' phenomenon," J. Derral Mulholland, of the University of Texas at Austin told SCIENCE NEWS. "The frequencies 'beat' together so that sometimes they add together, sometimes they cancel each other out. If you look but don't know there are two frequencies, it looks like variable amplitude and variable period. People who look at geophysical theories can't imagine how that could happen. Observers say that it *does* happen and that the theory is wrong."

In the March 10, 1981 JOURNAL OF GEOPHYSICAL RESEARCH, William Carter of the National Geodetic Survey reports that his analysis of observational data shows a correlation between the magnitude of the polar motion and variations in the beat period—the time required for the pole to complete a cycle of the combined annual and Chandler motions. His conclusions echo Chandler's in 1901. The reason for the variation in frequency, Carter suggests, is that the oceans fail to respond quickly to the changing orientation of the axis of rotation to the solid earth. The frequency of the wobble decreases as the poles become further displaced.

The Chandler wobble also affects—and is affected by—the one-half to one-centimeter variation called the pole tide, the response of the oceans when the earth wobbles. The tide is small enough to inspire skepticism in some facets of the

scientific community although, as Steven Dickman, a geophysicist at the State University of New York at Binghamton, explains, "From a theoretical point of view, it has to be there." In some locations, such as the North and Baltic seas, pole tides as large as three to five centimeters have been measured. "If the oceans respond more than people predict, it means the wobble is affected more than people predict," Dickman says. He suggests that the oceans are dissipating the energy as the waters, wobbling, rub against the sea floor.

To settle some of the controversies, better techniques of measuring polar motions and planet rotation are needed. In 1899, on the still-naïve assumption that the wobble was of simple nature with a fixed period, the International Latitude Service (ILS) was established as a short campaign to monitor polar motion. The ILS, one of the oldest international efforts of scientific collaboration, operated five observatories around the world, all on the same latitude, to measure annual, semiannual, and random polar motions in addition to the Chandler wobble. While this work, expanded into the International Polar Motion Service, continues with support from NASA, the National Geodetic Survey (NGS) under the National Oceanic and Atmospheric Administration has embarked on a program to monitor earth rotation using space technology. An experimental, international program, 14 months long, will begin September 1983 to test observational methods. The most accurate method wins, becoming the vehicle of choice for a leap in the quality of observations of polar motions.

The techniques being tested include classical methods based on visual, photographic and photoelectric observations of stars, and modern methods such as doppler tracking of earth satellites, laser ranging using the moon or satellites and the method favored by the NGS—radio interferometry. The technique, called Very Long Baseline Interferometry (VLBI), uses extragalactic radio sources billions of light years from earth. Under a project called POLARIS the NGS uses three observatories to monitor the earth's orientation with respect to the extragalactic radio sources, primarily quasars. Where traditional methods track polar motion and the planet's rotation to an accuracy of about a meter, VLBI allows measurements accurate to five to 10 centimeters.

Study of tiny details of the planet's rotation is just one aspect of the effort to learn more about the earth's structure. Says Dickman: "It's one of the most specialized topics capable of telling us some of the most generalized information about the earth, such as properties of the core or the elasticity of the mantle. It presents an endless number of research problems, each of which can tell us a little more about the earth as a whole." □
